Adoptive Parent's Agreement

I, _____ today agree to provide care to _____

This includes adequate food, water, exercise, shelter, veterinary care, and lots of love. The dog will live in the house as part of the family and will not be tethered or caged outside. The dog MUST wear full ID with ARAN's phone number and the current council registration tag, at all times during the trial period. After that, the new owner will provide the dog with an identity disc to wear at all times.

Unless the dog has already been desexed, I agree to have the dog, _____ desexed before the age of 6 months (if aged under 5 months) or within 4 weeks from the adoption date (if aged over 5 months) by my Veterinarian. Registration and all necessary vaccinations will be kept up to date: this is non-negotiable as ARAN must be sure that their rescue dogs are safe.

I understand that dog training/obedience classes are mandatory for ARAN rescue dogs – most of these dogs come from backgrounds where they have had little to no socialisation or training and this is a strict term of adoption.

I agree never to give away, sell, trade, or surrender the dog to any person or agency and that, in the event of my being unable to keep the dog, will surrender the dog back to ARAN Animal Rescue.

I understand that ARAN retains the right to remove the dog at any time if it comes to ARAN's attention that the above terms have not been adhered to, and/or any mistreatment of the dog occurs. Further, I shall have no claim against ARAN Animal rescue if I suffer any loss arising from a third party asserting to or having better title to the animal.

I agree that, after a trial period of 2 weeks, the adoption fee is non-refundable and there is no reimbursement if the adoption does not work out after this trial period, unless agreed upon by Aran Animal Rescue. I understand that until adoption is finalised in full after the trial period, the dog remains in ARAN's ownership and can be uplifted at any time by ARAN.

I agree that all expenses incurred after I take possession of _____ will be my sole responsibility and that ARAN Animal Rescue is released from any and all liabilities whether financial or other.

I understand that ARAN Animal Rescue has rescued this animal from the Pound/Shelter stated above and may have no prior information of age, breed, health issues, training, registration or other. Any information shared by ARAN Animal Rescue is of their own experience with the dog and ARAN Animal Rescue makes no warranties of any kind concerning the dog.
